- an **Application to End the Occupancy and Evict the Member based on Non-payment of Regular Monthly Housing Charges and to Collect the Housing Charges that the Co-op Member Owes (Form C1).**
- an **Application to End the Occupancy of the Member Unit and Evict the Member (Form C2).**

- Reason 2:** The Co-op is applying for an order to end the occupancy and evict the Co-op member **and** to collect the regular monthly housing charges and other charges the Co-op member owes up to the date the Co-op member moves out of the member unit.
